## **APTA Federal President's Message**

APTA Federal members.

I hope your holidays were busy and full with celebrations. We have a lot of news to share so going to jump right in. There are some challenges ahead of us as a Section even while we also have terrific opportunities. Tough news does not get better with delay so first to the challenges.

Our greatest challenge for 2024 and probably into 2025 is finances. We watched CSM costs increase last year and in anticipation worked to reduce our operating cost. While we were successful and we remain financially solvent, there is no way to mitigate the painful CSM cost increases. For example, preconference course AV support increased from ~\$1000 pre COVID to a projected \$7,000/course in Boston. Catering and other costs have also increased. While we've historically done well at CSM, and occasionally made a nice profit, this year at CSM you will see some belt tightening.

What we've done to reduce costs over the past two years:

- 1. Move the Board's annual strategic planning meeting to online for 2022, 2023 and 2024
- 2. Increase calendar year 2024 membership dues by 25% for PTs with scaled increases for all others

- 3. Peg catering for precon courses to the dollar amount over the break even point for each course in 2023; consider no catering for any precon for 2024
- 4. Reduce or eliminate catering from APTA Federal events at CSM
- 5. Invest in a website that will allow other revenue streams (i.e., education) as well as allow us to reduce our digital footprint costs (e.g., moving all Basecamp activities to the website)

Meanwhile, as Chair of the Council of Section Presidents, I've led discussions with APTA on future projected costs for CSM 2025 and beyond, as well as led multiple rounds of review, comment and adjustment to the CSM Agreement between APTA and the Sections and Academies.

APTA Federal remains committed to supporting our members with awards, scholarships and the other benefits of membership. We hope to continue those support activites and will keep you informed as the year progresses.

Now on to the opportunities. Over 2023, the Section accomplished much: a new website, updated Bylaws, an overwhelming response to the call for nominations for new Board and Leadership positions, and selection of the final new leadership position, Research Chair. These are all major milestones for the Section. Thank you to everyone who has volunteered to serve our community.

Among the "vexing questions" that were debated by the 63 attendees (TODAY WE EXPECT 15,000 ATTENDEES, 18 Sections, 420 educational programs and 1300 poster presentations): Should "qualified" male physical therapists be admitted? Should the APTA constitution define minimum requirements for general education and specialized training?

Highlights of the convention included presentations on electrotherapy, exercise therapy, and hydrotherapy, and even a "paper with lantern slides" on posture training by physical therapist Inga Lohne. (Lohne, incidentally, became APTA's second president the following year.) Physician Frank Granger led clinical observations on muscle reeducation at Boston City Hospital." ## **Air Force PT Update**

Federal physical therapy practice is both demanding and rewarding. Each military branch and federal organization come with their own benefits, and it is important to be as informed as possible when choosing to pursue military service. This information on benefits for United States Air Force physical therapists is current at the time of writing this update, but is always subject to change. Talking with your health professions recruiter would be the appropriate place to start. As always, my

#### Financial Incentives:

- Student Loan Repayment: Individuals with federal student loans obtained while completing their entry level physical therapy degree may apply to participate in the Health Professions Loan Repayment Program (HPLRP). Currently, this involves up to \$80,000 total (\$40,000/year over two years), minus taxes which are taken out initially prior to disbursement.
  - o AFIT / Civilian Institution Programs / Health Professional Loan Repayment Program
- New Accessions Bonuses: This varies in availability and quantity per year based on needs of the Air Force and budget.

- Board Certification Pay: This currently is \$8,000/year, for the following ABPTS specialties: Cardiopulmonary, Clinical Electrophysiology, Geriatrics, Neurology, Orthopedics, Pediatrics, Sports, Women's Health, Wound Management, Oncology.

**Educational Opportunities**: There are opportunities for post-professional educational programs where members are competitively selected. #### **NEW ARMY CAREER MAP PUBLISHED:**

The Army Physical Therapy Community recently conducted an overhaul on the 65B career map in Army Career Tracker. Major changes were made to key developmental and broadening/strategic billet assignments with updated terminology for unit types, position titles, and long-term health education and training (LTHET) offerings. The military treatment facility positions were prioritized at the top as foundational to emphasize that these positions are critical prior to progressing to broadening and operational assignments to build strong clinical and leadership skillsets that enable readiness. The institutional domain of functional training section was also modified to reflect the most current short course offerings in the US Army and the Department of Defense and now highlight specialty board certification, individual professional continuing education courses, and research activities. This updated 65B career map will provide support to officers and leaders in counseling sessions and while competing in the AIM marketplace. It is available for download at the Army Career Tracker website.

#### **MUSCULOSKELETAL ULTRASOUND:**

The availability and utilization of musculoskeletal (MSK) ultrasound are growing across the PT profession as an emerging area of practice. Handheld ultrasounds provide a low-cost portable means for military PTs to perform MSK ultrasound in field environments. Join CPT Jordan Pruitt (pictured) and MAJ Jon Umlauf at CSM in 2024 for a hands-on introductory course on MSK Ultrasound Course, where they will share how MSK ultrasound can assist PTs in making better-informed rehabilitation decisions at the point of injury.
